

Mill Road Closing Alert

Over the next several weeks, Atlantic City Electric will be installing new metal power line poles along Mill Road from California Avenue to Stewart Lane (just north of the intersection with Wescoat Road) At various times, sections of Mill Road will be closed to all traffic except businesses and residences along the area of construction. Atlantic City Electric has issued the following advisory providing specific direction to motorists.

FROM DECEMBER 10TH, 2014 UNTIL DECEMBER 22ND 2014, MILL ROAD WILL BE CLOSED DURING THE HOURS OF 7AM UNTIL 7PM (MONDAY THRU FRIDAY). THE CLOSURE WILL BE LOCATED ON MILL ROAD FROM CALIFORNIA AVE TO WESCOAT ROAD. DETOUR SIGNS WILL BE IN PLACE AND DRIVERS ARE URGED TO UTILIZE ALTERNATE ROUTES TO PROCEED TO THEIR DESTINATIONS.

FROM JANUARY 5TH 2015 UNTIL FEBRUARY 15TH 2015, MILL ROAD WILL BE CLOSED DURING THE HOURS OF 7AM UNTIL 7PM (MONDAY THRU FRIDAY). THE CLOSURE WILL BE LOCATED ON MILL ROAD FROM ROUTE 30 UNTIL WESCOAT ROAD. DETOUR SIGNS WILL BE IN PLACE AND DRIVERS ARE URGED TO UTILIZE ALTERNATE ROUTES TO PROCEED TO THEIR DESTINATIONS.

(ALL DATES AND TIMES ARE WEATHER PERMITTING)

LOCAL RESIDENTS AND BUSINESS IN THE AFFECTED ROAD CLOSURE AREAS ARE ASKED TO BE PATIENT AND APPROACH OFFICERS OR TRAFFIC SAFETY REPRESENTATIVES PRIOR TO ENTERING THE CLOSED AREA. YOUR SAFETY IS OF OUR UTMOST CONCERN AND SOMEONE ON SCENE WILL ASSIST YOU TO YOUR DESTINATION. PLEASE BE PREPARED TO PROVIDE IDENTIFICATION TO THE

OFFICER OR TRAFFIC SAFETY REPRESENTATIVE. DRIVERS WILL BE DIRECTED AROUND THE SITE IF THEIR DESTINATION IS NOT WITHIN THE CLOSURE AREA OR IF THEIR DESTINATION MAY BE OBTAINED IN A SAFER MANNER.

THOSE ENTERING A CLOSED ROADWAY WITHOUT PRIOR APPROVAL MAY BE SUBJECT TO MOTOR VEHICLE VIOLATIONS FOR THEIR ACTIONS.
