*The flu vaccine cannot prevent all cases of the flu, but it may help reduce the likelihood of contracting the virus and lessen its severity and duration, which is especially important during the Covid-19 pandemic. Residents can help prevent the spread of both flu and Covid-19 by continuing to follow recommended hygiene protocols including wearing facemasks, washing hands frequently, covering coughs and sneezes and cleaning commonly touched items.*
