ORDINANCE 16-2018

AN ORDINANCE AMENDING THE CODE OF THE CITY OF ABSECON, CHAPTER 35, SECTION 19 – LENGTH OF SERVICE AWARD PROGRAM FOR THE ABSECON VOLUNTEER FIRE DEPARTMENT AND THE ABSECON EMERGENCY SERVICES, INC.

NOW THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF ABSECON CITY, NEW JERSEY that Chapter 35, Section 19 be amended as follows:

Amend Paragraph 3 subsections B and C as follows:

- B. Points shall be awarded according to Schedule A for the Absecon Volunteer Fire Department and Schedule B for the Absecon Emergency Services, Inc.

**SCHEDULE A
FIRE DEPARTMENT**

<u>CATEGORY</u>	<u>POINTS</u>
FIRE CALL RESPONSE <u>Includes:</u> Fire, Hazardous Condition, Alarm, Rescue, Accident, Police/EMS/Public Works Assist, Cover-Up Assignment, Fire Police, Stand-By, Task Force or Strike Team	3 points maximum per incident
OPERATIONS, MAINTENANCE AND TRAINING <u>Includes:</u> Familiarization of Structures and Preplans, Fire Prevention Education Detail, Parade Detail, Public Relations Detail, Work Detail, Funeral Detail, Maintenance and Repair of Apparatus/Equipment/Building/Grounds, Comprehensive Apparatus Equipment Check, and Training	1 point per hour, not to exceed 3 points per incident
ADMINISTRATION	50 points maximum per volunteer
Chief or President	25 points
Other Officers	15 points
Committee Member or Delegate	10 points
Department Meetings	1 point per hour, not to exceed 3 points per incident

**SCHEDULE B
ABSECON EMERGENCY SERVICES, INC.**

Duty Shift Day 6 hr	8
Duty Shift Day 12 hr	10



Special Event Standby	3
TRAINING – 150 Suggested	
EMT Class & Certification	150
Core CEU or Elective Credit	3

ADMINISTRATION – 50 Maximum	
Chief, President, Trustee	25
Other Officer	15
Delegate, Chair, Director	10
Meetings, each	1

C. Schedule A represents the maximum and minimum points that can be awarded within the categories listed in all cases. Fire call response incidents must represent a minimum of 250 points to qualify for the maximum award level. For all other levels, Fire Call Response incidents must represent a minimum of 50% of total points in order to qualify for that level. Points awarded for the Operations, Maintenance and Training section are unlimited. Administration points awarded may not exceed 50 points per volunteer.

BE IT FURTHER ORDAINED that

1. Any Ordinance or parts of ordinances which are inconsistent with the provisions Of this Ordinance are hereby repealed to the extent of any such inconsistency.
2. This Ordinance shall take effect upon final adoption and publication as required by law.
